BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF

Services included, but not limited to: (1) responding to the initial request for service; (2) conducting the arrangement conference; (3) preparation of biographical and statistical data; (4) examination of financial settlement options; (5) preparation and filing of papers, permits and authorizations; (6) coordination with those providing other services; (7) preparation and placement of obituary notices; (8) retention and care of remains prior to commencement of post-death activities; (9) overhead expenses relative to our facility and operations, such as occupancy, administrative and equipment costs.

This fee for our basic services will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

EMBALMING

(including use of preparation room and sanitary care)

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. If you choose to have an embalming performed, the decedent may be embalmed at a location other than this registered mortuary.

No human remains may remain unburied or uncremated in New Jersey for more than 48 hours unless embalmed or refrigerated. (N.J.A.C. 8:9-1.1)

VIEWING AND VISITATION AT OUR FUNERAL HOME

Use of facilities and staff for viewing, including setup of the visitation area, placement of remains, positioning of floral displays, and supervision and attendance during the hours of visitation.

VIEWING AND VISITATION AT ANOTHER FACILITY

Use of staff and equipment for local transportation (within 10 miles) of remains, including setup of the visitation area, placement of remains, and supervision and attendance during the hours of visitation.

FUNERAL CEREMONY

Use of facilities and staff for funeral ceremony, including coordinating the arrangements for the ceremony, staff supervision and attendance, and the use of the funeral home when used for the ceremony.

MEMORIAL SERVICE (without body present)

AT THE GRAVESIDE SERVICE (whether at cemetery or crematory)

SHELTERING OF REMAINS



This list does not include prices for certain items that you may ask us to buy for you, such as cemetery or crematory services, flowers and newspaper notices. The prices for those items will be shown on your bill or the statement describing the funeral goods and services you selected.

This package charge includes local transfer (within 10 miles) of remains to this funeral home, basic services of funeral director and staff, sheltering of remains for up to 48 hours, embalming, obtaining necessary permits and authorizations (but not the actual cost of death certificates, permits and filing fees) and transportation of remains to Newark Liberty International Airport. It does not include a casket or alternative or shipping container, the use of facilities and staff for any visitation or ceremony—public or private—prior to forwarding the remains, or any sheltering for days on which no post-death activities occur. Nor does it include the charges of a common carrier.

RECEIVING OF REMAINS FROM ANOTHER FUNERAL HOME

This package charge includes receiving the remains from another funeral home, transfer of remains from Newark Liberty International Airport to our funeral home, sheltering of remains for up to 48 hours, basic services of funeral director and staff, obtaining necessary permits and authorizations (but not the actual cost of death certificates, permits and filing fees) and local transportation (within 10 miles) to the cemetery or crematory. It does not include the use of facilities and staff for any visitation or ceremony—public or private—prior to burial or cremation, or any sheltering for days on which no post-death activities occur. Nor does it include the charges of a common carrier.

IMMEDIATE BURIAL

Our package charges for immediate burial include basic services of funeral director and staff, local transfer (within 10 miles) of remains to this funeral home, sheltering of remains for up to 48 hours, obtaining necessary permits and authorizations (but not the actual cost of death certificates, permits and filing fees), local transportation to the cemetery. This charge does not include the use of facilities and staff for any visitation or ceremony—public or private—prior to burial, or any sheltering for days on which no post-death activities occur. Nor does it include the actual cost of the grave at the cemetery, or the cemetery's charges for opening and closing of the grave or an outer burial container (if required by the cemetery).

DIRECT CREMATION

Our package charges for direct cremation include basic services of funeral director and staff, local transfer (within 10 miles) of remains to this funeral home, sheltering of remains for up to 48 hours, obtaining necessary permits and authorizations (but not the actual cost of death certificates, permits and filing fees), local transportation to the crematory. This charge does not include the use of facilities and staff for any visitation or ceremony—public or private—prior to cremation, or any sheltering for days on which no post-death activities occur. **Nor does it include the actual cost of the cremation process which is a crematory charge that is detailed below.**

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). *The containers we provide are cardboard.*

HISTORY

In 2014, Frank Jr.'s children decided to devote all of their time towards their own separate careers, passing along the funeral home to Daniel and Joan Bitecola, along with their sons, Clifford Bitecola and our current manager, Daniel Bitecola III. While Clifford is not active in the funeral home operations, you will continue to see him from time to time.

Since the Bitecola family has owned the funeral home, they have become a fixture in Bloomfield and the surrounding communities. Their service reaches beyond the funeral industry. They are immersing themselves in various church activities, assisting with several charities, and sponsoring fundraisers and events from police and fire departments. The funeral home sponsors and supports several youth sports teams; our staff even assists with coaching. Renovations began to update the facilities with more modern amenities while keeping the home-like setting. A few more team members have joined our team. Daniel Bitecola III's wife, Melanie, started working part-time in 2015 when she found her passion for assisting families. She became a licensed funeral director in 2019. In 2018, Annalyse Juarez began part-time while completing her funeral director internship. In 2019, Annalyse became a first-generation licensed funeral director.

With a tradition for service, in 2017, Halpin-Bitecola Brookdale Funeral Home won its first of five National Funeral Directors Association's prestigious Pursuit of Excellence Awards. In 2019, Daniel and Melanie won the Spotlight Award from the Suburban Essex Chamber of Commerce for their community involvement. Daniel was awarded Bloomfield Police PBA Business Man of the Year in 2022. In 2025, Melanie was honored with the Bloomfield Women to Watch award during Women's History Month. In addition, Halpin-Bitecola was invited to join the Selected Independent Funeral Homes Association in 2022.
